



FUND OBJECTIVE & STRATEGY

The Fund aims to generate income in excess of money market rates combined with modest capital growth by investing in a range of fixed income assets including cash, NCD's, preference shares, government and corporate bonds and inflation-linked bonds. The Fund may hold listed property and equity, with weightings limited to the sector classification limits. The Fund aims to generate a gross return of CPI plus 1% - 2% over a rolling 12 to 24 month period whilst having a high degree of capital stability. The average duration of the funds investments will typically be in the range of 2-4 years.

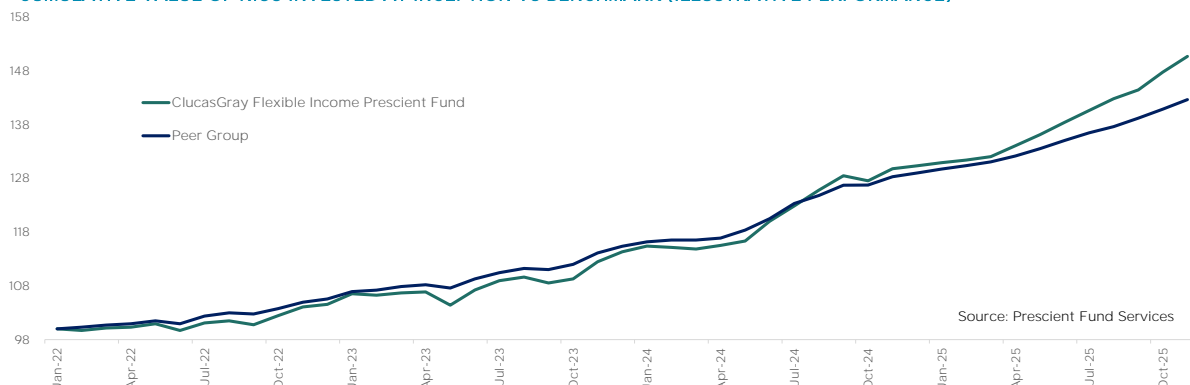

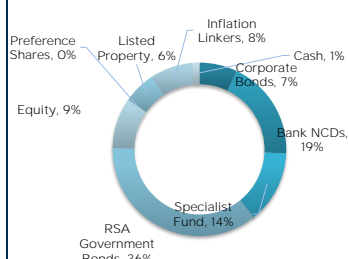

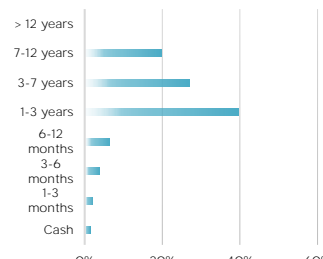

**QUARTERLY COMMENTARY | SEPTEMBER 2025**

The 3rd quarter of 2025 saw a continuation of the strong period for domestic bond investors. The ALBI was up 6.9% for the quarter and is now up 14% for the year to date. The 12 month trailing returns from the ALBI are very healthy being up 14.5%. Whilst returns from inflation linked bonds have been respectable over the last 12 months (7.7%) they have underperformed nominal bonds significantly, with nominal bonds benefiting from the combination of the elevated yield as a starting point, a benign domestic inflation outlook and the prospect of further interest rate cuts.

The ClucasGray Flexible Income Prescient Fund grew by 4.4% over the quarter, 12.4% over the last year and by 12.8% per annum over 3 years. These returns compare favourably to funds objective of inflation plus 2% over a 12 to 24 month rolling period.

We have previously commented on the performance of South African bonds relative to the World Government Bond Index (WGBI). SA Bonds have continued to perform extremely well in a global context – outperforming their global peers by approximately 12.5% (in USD) over the last 12 months. The nearer term relative outperformance is even more significant given the recent strength of the Rand. For the year to date, the WIBGI is up 7.4% (USD) whilst the ALBI is up 24% (USD), a remarkable outperformance of 17%.

The fund asset allocation is set out below. The changes made to the overall fund allocation were primarily driven by flows over the quarter. The portfolio is well exposed to bonds (47%) and in conjunction with the exposure to property (6%) and equities (10%), these were the primary drivers of the recent returns. The NCD exposure is approximately 21% and provides a steady underpin to the portfolio.

For each asset class we highlight material activity over the quarter. Within bonds, we added to existing positions (R213, R2032, R2033 and R209) and introduced a new position in the R2035 bond. Within equities we added two new positions, namely Life Healthcare and Sun International on the basis that they can grow their dividend distributions in real terms over the foreseeable future. These purchases were funded by reducing the holding in BTI. Within the property sector we increased our weighting to Redefine properties. Additional NCD's with 18-month duration were purchased to maintain our exposure and maturity profile.

The fund has adhered to its policy objective, and our view is that the current combination of assets leaves the fund well positioned to deliver on its real return objective of inflation plus 2% over a rolling 12-to-24-month period

It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.
