

**FUND OBJECTIVE & STRATEGY**

The Fund aims to generate income in excess of money market rates combined with modest capital growth by investing in a range of fixed income assets including cash, NCD's, preference shares, government and corporate bonds and inflation-linked bonds. The Fund may hold listed property and equity, with weightings limited to the sector classification limits. The Fund aims to generate a gross return of CPI plus 1% - 2% over a rolling 12 to 24 month period whilst having a high degree of capital stability.

The average duration of the funds investments will typically be in the range of 2-4 years.

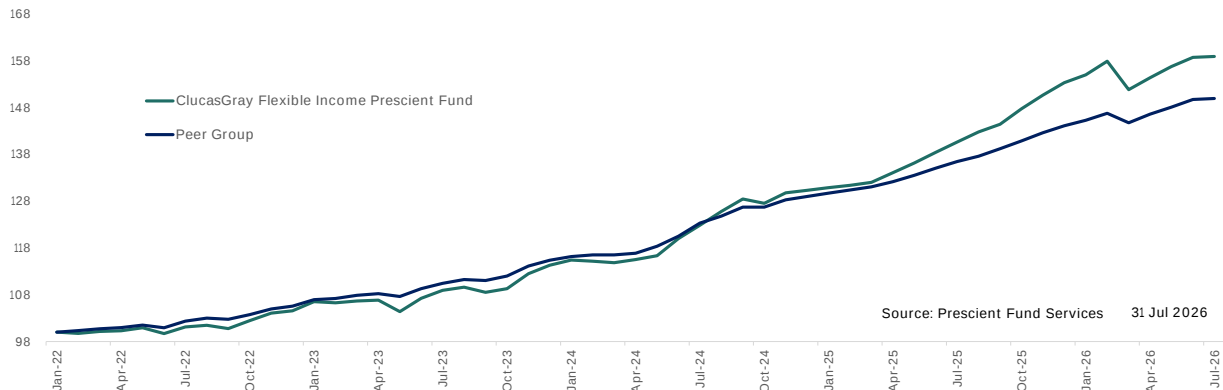

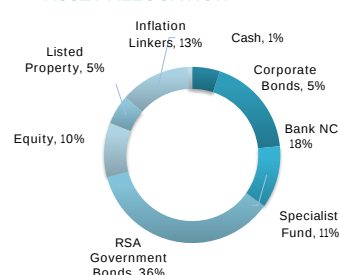

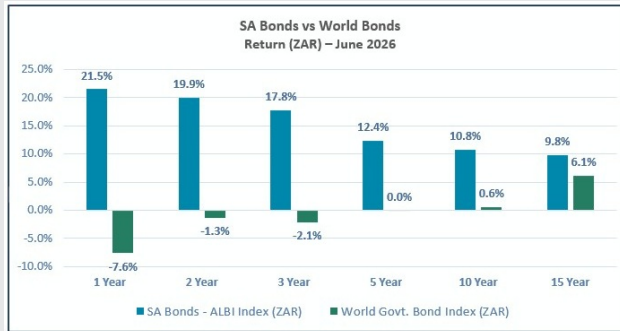

QUARTERLY COMMENTARY | JUNE 2026

Bonds delivered a strong recovery (+7,9%) in the second quarter of the year following the negative first quarter in the wake of the Middle East crisis. The ALBI is now up +4,2% for the year to date, and the 12-month rolling performance is very still very strong at +21,4%. The ALBI has now outperformed the All Share Index over the last 12 months, and the 3-year annualised returns from the ALBI of 17,8% match that of the All Share Index. Inflation linked bonds have continued to be resilient, rising 6,5% for the quarter and are up 5,3% for the year to date. Global bonds (measured by World Govt Bonds in USD) were marginally positive for the quarter but remain down -0,4% for the year to date. The continued longer-term outperformance of SA Bonds over their global counterparts has been astonishing, highlighted in the chart below.

The ClucasGray Flexible Income Prescient Fund was up 4,5% over the quarter and is up 3,5% for the year to date. The 12-month trailing returns remain strong at 14,6% and the fund has now grown at a compound rate of 14% over 3-years. We continue to assess the optimal combination of the key asset classes to which it is exposed - domestic bonds, equity and property assets. The current fund asset allocation is set out below.

The primary changes to the fund holdings and asset allocation over the quarter involved adding to NCD's, where we saw a short-term spike in rates, providing an opportunity to extend the funds NCD duration in the 12,18 and 24 month range. In addition, we continued to build on the exposure to inflation-linked bonds, via the I2033 instrument.

The fund has adhered to its policy objective, and our view is that the current combination of assets leaves the fund well positioned to deliver on its real return objective of inflation plus 2% over a rolling 12-to-24-month period. The current running yield estimate is 7,9% with a duration of 2,9. We paid out total distribution of R6.7 million for Q2.

The number of participatory units at 30 June 2026 was 286 213 219.

DISCLAIMER

During the phase in period TER's do not include information gathered over a full year.

Transaction Costs(TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month.
